Objective

These discretionary managed model portfolios offer risk-profiled investment solutions, all of which have a dynamic top-down asset allocation strategy implemented using low cost index tracking funds. The investment objective for the EPIM Cabot Moderately Cautious Model Portfolio is to provide a long-term total return which is superior to the UK CPI inflation rate plus 1%. The performance of the model portfolio is not intended to track the rise (or fall) of any specific index.

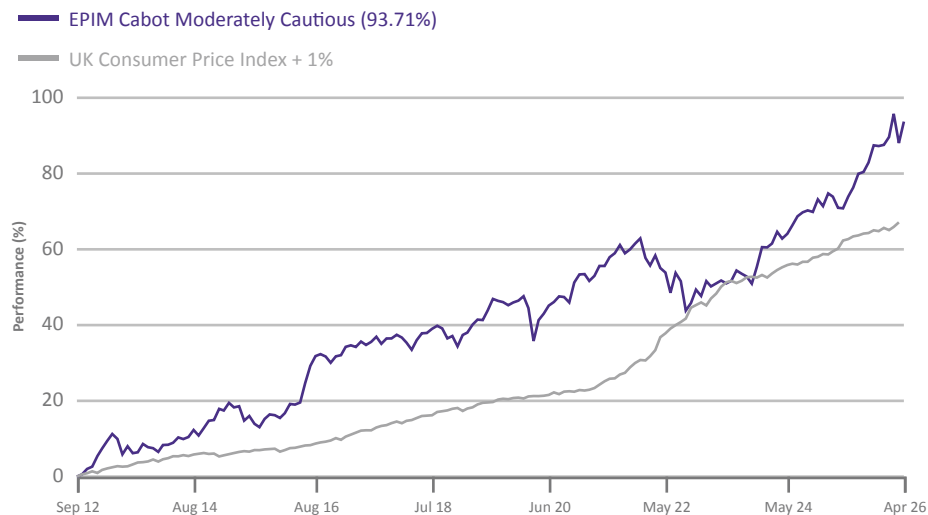
