# Investment objective and policy

This discretionary managed model portfolio offers a cash equivalent solution using Low Volatility Net Asset Value (LVNAV) money market funds. These funds will be members of the IMMFA (Institutional Money Market Funds Association) and have a minimum AUM of £5bn.

The investment objective for the Eden Park Money Market Portfolio is to provide access to attractive institutional cash returns with daily liquidity.

# Investment Team

The model portfolio is managed by Eden Park Investment Management, with investment advisory services provided by Charles Stanley.

The team of portfolio managers have extensive experience managing models and together with the research team looks for the best money market funds from the available IMMFA (Institutional Money Market Funds Association) universe.


