Objective

These discretionary managed model portfolios offer risk-profiled investment solutions, investing predominantly in actively managed, third-party funds. The investment objective for the EPIM Income Moderately Cautious portfolio is to provide a long-term total return which is superior to the UK CPI inflation rate plus 1%. We will invest predominantly in asset classes which have a yield, and in funds that enable that yield to be paid out as income. The performance of the model portfolio is not intended to track the rise (or fall) of any specific index.

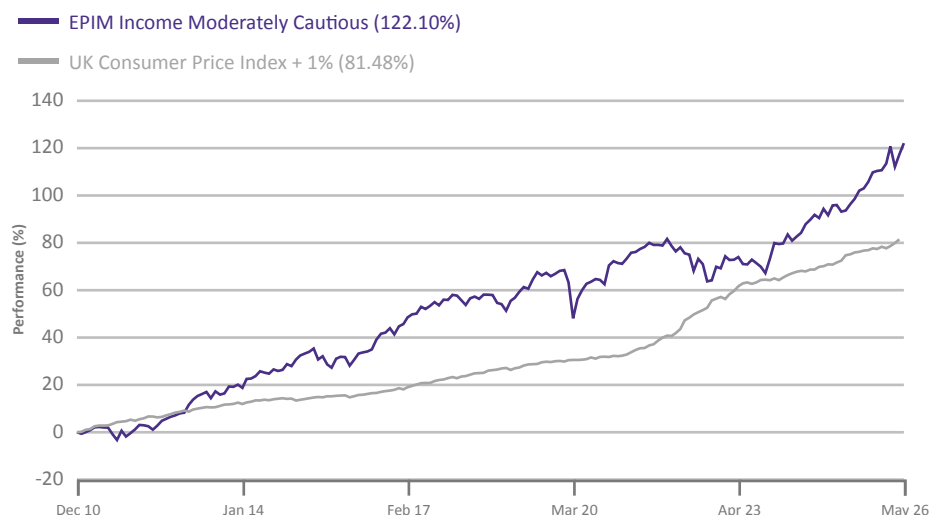
