

EPIM Cabot Global Equity

Investment objective and policy

These discretionary managed model portfolios offer risk-profiled investment solutions, all of which have a dynamic top-down asset allocation strategy implemented using low cost index tracking funds.

The investment objective for the EPIM Cabot Global Equity Model Portfolio is to provide a long-term total return which is superior to inflation plus 4% returns. The performance of the model portfolio is not intended to track the rise (or fall) of any specific index.

Equity markets mostly rallied in November, with gains driven by mounting hopes that the US Federal Reserve (Fed) will slow the pace of interest-rate rises before Christmas. This follows an aggressive campaign to tame inflation that has weighed heavily on equity markets. At the beginning of November, ongoing concerns about inflation and further central bank tightening were at the forefront of investors' minds. However, despite continued steep increases in policy rates from the Bank of England (BoE) and the Fed, bond markets registered a strong month across the board, with yields falling generating a positive total return.

Despite strong employment data in the US, and high inflation prints in Europe, bonds rallied through the month on the hope that aggressive interest-rate hikes were nearing an end and the pace of tightening of financial conditions would moderate. In the UK, the much-anticipated Autumn Statement signalled that the government would be working in lockstep with the BoE. This gave the market some comfort that future rate hikes may need to be less aggressive – despite continued high inflation.

Meanwhile, in the US and Europe, central banks' tone became more moderate, recognising the impact of rate hikes so far and becoming more vocal about their wish to avoid a steep downturn. It is likely that inflation has peaked in the US and elsewhere – and it should fall sharply during 2023. Nevertheless, the rate of price increases remains extremely elevated – and it will take some time before clear evidence emerges that inflation is heading towards target levels.

Central bankers need to ensure that the brakes they are putting on economic growth are strong enough to impact prices, but not so intense that they cause the slowdown to overshoot. Recent data suggests authorities are on track to achieve their aims, but the economic slowdown is likely to limit market returns until economic data clearly improves.

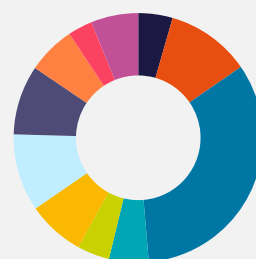

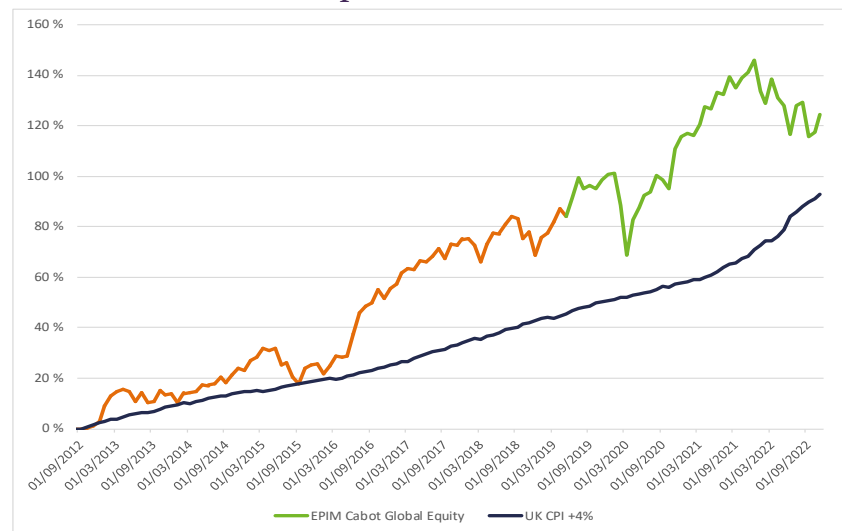
